Learn initial aspects of Assessment and Diagnosis of Psychiatric Disorders using DSM 5 Utilize theory and best practices in the choice of counseling techniques with individuals exhibiting specific diagnoses Conduct an on-going risk assessment for suicide, homicide, violence, etc. Assess the impact of acute and chronic medical problems on psychiatric treatment Apply components of culture, diversity, and recovery to the development of a treatment plan Plan systems interventions utilizing evidence-based practice Incorporate screening guidelines into plan of care to foster health promotion/ risk reduction. Plan educational interventions to foster patient understanding of mental illness and treatment. Examples include: o Social Workers o Counselors/Therapists o Psychologists o Substance Abuse Counselors o Group therapists Providers must be able to meet with student to discuss therapy sessions and to supervise/assist student's growth as a psychotherapist. **Psych NPs and Psychiatrists do not qualify, as they tend not to focus enough on psychotherapy to provide adequate learning opportunities for students.

* For students planning to complete clinical activity in California for ANPS8020: Psychiatric Nursing NP Practicum I: The California Board of Registered Nursing outlines that preceptors must be an NP, physician, psychiatrist (pending approval from the program director), or clinical psychologists. Therapists and counselors are not considered appropriate preceptors for these clinical experiences in California.

- It is acceptable to have more than 1 preceptor for each clinical course; however, a student should not have more than 2 preceptors per semester.
- Up to 204 clinical hours may be earned utilizing telepsychiatry educational modality. Students must have 100 in-person hours in each of 3 age demographics.
- A minimum of 40 hours with each preceptor is required. Students who wish to acquire additional hours (over 168 hr) during a semester must obtain permission from Dr. Tyson, the program director.
